5. APPROVAL OF MINUTES

A. Presentation on "Report an Issue" Website Feature and City Mobile App - Albert Nuñez, Management Aide

The Commissioners suggested City staff conduct a survey on Duarte FlashVote to analyze how many residents have access to the PEG Channel.

Assistant City Manager/Director of Administrative Services Petersen provided an update on the Assistant to the City Manager recruitment process.
